It's my privilege to inform you that the associate degree Human Services Program at Montgomery County Community College has been accredited by the Council for Standards in Human Service Education (CSHSE) for the period June 2018 through June 2023.

PROGRAM STRENGTHS

The readers of your self-study have identified the following strengths of your program including:

- A 40-year history of excellence in the field of human services in the community and the college.
- Numerous Articulation Agreements with other schools and community partners.
- A multi-disciplinary curriculum allows faculty to teach perspectives from human services, psychology, sociology, and other social sciences.
- A large and active advisory board guides the direction of the program's curriculum and activities
- Use of the Academic Report Card gives basic and thorough information about the program's strengths and student outcomes.
- Over 4 generations of faculty who have graduated from this program are now teaching and mentoring program students

REQUIREMENTS FOR NEXT ACCREDITATION

The following recommendations, although not required, are submitted for your consideration:


Clarify course assignment weights: Although the syllabi are very thorough and include learning objectives, assignments, and evaluations, as well as a rubric for each course, there are no assignment weights. It is indicated that students must pass each course with a grade of C, but there are no indications of how much each assignment is worth in each syllabus. This makes grading inconsistent if instructors are not assigning the same weights to the assignments in their classes.

It was agreed by all three readers that the Human Service Interim Report from Montgomery County Community College was comprehensive, well written, easy to read, had sufficient documentation, and included changes made to the program based upon recommendations by the Council in 2013.

As stated above, your next reaccreditation with a site visit will be June 2023. Please review information on our website, www.cshse.org for any new policies and standards related to the Associate degree program. The program must also ensure that your Program and Student Achievement Indicator links on the CSHSE website remain active during this accreditation period. This letter must be submitted with your next reaccreditation self-study.

Congratulations on continuing your program accreditation and becoming one of our exemplary accredited programs! A formal certificate, signed by our President, Elaine Green, will be forthcoming.
