Application for Initial Accreditation, Interim Report and Review, or Reaccreditation of Human Service Program

The accreditation process can vary in duration based on the institutional and curriculum processes. Programs are encouraged to contact the Vice President of Accreditation or a Board Member-at-Large prior to submission of the Accreditation Application Form. See https://cshse.org for current contact information.

Programs must be current members of the Council to apply for Initial Accreditation, Interim Report and Review, or Reaccreditation, and annual membership must be maintained as a condition of accreditation.

Directions for completing the self-study and a timeline for Council approval is available in the *Member Handbook: Accreditation and Self-Study Guide* which is available in PDF format on the Council website. Accreditation is approved for five years.

From the date of Application, programs have two years to complete the Initial accreditation process. Refer to the Member Handbook: Accreditation and Self-Study Guide for Interim Review and Report and Reaccreditation timelines.

The accreditation process includes completion of a self-study that is read and evaluated by independent readers and a site visit, when required, is conducted by representatives of the Council. A Board Member-at-Large is assigned and serves as a program's consultant during the self-study process and is not allowed to be a reader or site visitor for that program. Effective July 1, 2022, the following fees are assessed according to degree level and the number of sites:

\$750 for Associate degree

\$1000 for Baccalaureate degree

\$1250 for Master's degree

Sites: 10% of program degree accreditation fee for each additional site. For example, if the Baccalaureate program is offered at two sites, the accreditation fee is \$1000 plus \$200 (10% of \$1000=100 for one site) for a total of \$1200

Mail the completed accreditation application form (begins on page 2) and the accreditation fee with a check made payable to the Council for Standards in Human Service Education or CSHSE, Federal ID # 36-3706899, to the address above. If the same curriculum is used at multiple sites, they can be included in one self-study, but there is an additional \$50 charge for each additional site. Programs can opt to pay the fee with credit card directly online with the online application at the CSHSE webpage.
