Application for Accreditation of Human Service Program

The accreditation process can vary in duration based on the institutional and curriculum processes. Programs are encouraged to contact a Board Member-at-Large or the Vice President of Accreditation prior to submission of the Accreditation Application Form. See http://www.cshse.org for current contact information.

Programs must be current members of the Council to apply for accreditation, and annual membership must be maintained as a condition of accreditation.

Directions for completing the self-study and a timeline for Council approval is available in the *Member Handbook: Accreditation and Self-Study Guide* which is available in PDF format on the Council website. Accreditation is approved for five years.

From the date of Application, programs have two years to complete the initial accreditation process. Refer to the Member Handbook: Accreditation and Self-Study Guide for reaccreditation timelines.

The accreditation process includes completion of a self-study that is read and assessed by independent readers and a site visit by representatives of the Council. A Board Member-at-Large a reader or site visitor for that program.

Mail the completed accreditation application form (begins on page 2) and the \$500.00 accreditation fee (effective July 1, 2017) with a check made payable to the Council for Standards in Human Service Education or CSHSE, Federal ID # 36-3706899, to the address above. If the same curriculum is used at multiple sites, they can be included in one self-study, but there is an additional \$50 charge for each additional site. Programs can opt to pay the fee with credit card directly online at the CSHSE webpage and then mail only the application to ASCENT Management LLC.
